Upon submittal of a Development Engineering Plan application, the plat document shall be revised to show the existing sanitary sewer service that serves proposed Lot 2 within a 10 foot wide utility easement. If any portion of the easement is located on proposed Lot 4, then a design exception shall be obtained to allow a utility easement to cross one lot to serve another or the plat document shall be revised to ensure that the entire easement is located on proposed Lot 2. If an Exception is obtained, a copy of the approved Exception shall be submitted with the Development Engineering Plan application: 4. Upon submittal of a Development Engineering Plan application, the plat document shall be revised to show the existing water service line that serves proposed Lot 2 within a minimum 20 foot wide utility easement. Since the water service line extends across proposed Lot 4, a design Exception shall be obtained to allow a utility to cross one lot to serve another or the plat document shall be revised to ensure that the water service line is located exclusively on proposed Lot 2. If an Exception is obtained, a copy of the approved Exception shall be submitted with the Development Engineering Plan application; 5. Upon submittal of a Development Engineering Plan application, a drainage plan report prepared by a Registered Professional Engineer as per the Infrastructure Design Criteria Manual shall be submitted for review and approval if subdivision improvements are required. The drainage plan and report shall address storm water quantity control and storm water quality treatment in conformance with the Infrastructure Design Criteria Manual. In addition, easements shall be provided as needed; 6. Prior to Development Engineering Plan approval, engineering reports required for construction approval shall be accepted and agreements required for construction approval shall be executed. In addition, permits required for construction shall be approved and issued and construction plans shall be accepted in accordance with the Infrastructure Design Criteria Manual. All final engineering reports shall be signed and sealed by a Registered Professional Engineer; 7. Prior to approval of the Development Engineering Plan application, a Development Agreement shall be entered into with the City for all public improvements, if applicable; 8. Upon submittal of a Development Engineering Plan application, a cost estimate of the required subdivision improvements shall be submitted for review and approval; 9. Upon submittal of a Final Plat application, surety for any required subdivision improvements that have not been completed shall be posted and the subdivision inspection fees shall be paid; and, 10. Prior to the City's acceptance of the public improvements, a warranty surety shall be submitted for review and approval as required. In addition, any utilities and drainage proposed outside of the dedicated right-of-way shall be secured within easement(s).

Estes stated he needed to abstain from this item. Motion was made by Doyle, second by Drew and carried, with Estes abstaining, to Approve (No. 15PL112) A request by Sperlich Consulting, Inc. for Freeland Meadows, LLC for a **Preliminary Subdivision Plan** for proposed Lots 20 thru 35 of Block 1, Lots 2 thru 23 of Block 3 and Lots 14 thru 26 of Block 4 of Prairie Meadows Subdivision, generally described as being located northeast of the West Nike Road and Country Road intersection with the following stipulations: 1.Prior to submittal of a Development Engineering Plan application, driveway length(s) for Lots 26 and 27 shall be identified. If the length(s) exceed 150 feet, than an emergency vehicle turnaround shall be designed and constructed as a part of the subdivision improvements; 2. Upon submittal of a Development Engineering Plan application, for Giants Drive, Eli Drive and Marino Drive shall be submitted for review and approval showing the street(s) located within a

minimum 52 foot wide right-of-way and constructed with a minimum 26 foot wide paved surface, curb, gutter, sidewalk, street light conduit, water and sewer or Exception(s) shall be obtained. If Exception(s) are obtained, a copy of the approved Exception(s) shall be submitted with the Development Engineering Plan application; 3. Upon submittal of a Development Engineering Plan application, construction plans for Country Road shall be submitted for review and approval showing the street constructed with a minimum 36 foot wide paved surface, curb, gutter, sidewalk, street light conduit, sewer and a dual water main or an Exception shall be obtained. If an Exception is obtained, a copy of the approved Exception shall be submitted with the Development Engineering Plan application; 4.Upon submittal of a Development Engineering Plan application, construction plans for West Nike Road shall be submitted for review and approval showing the street located within a minimum 68 foot wide right-of-way and constructed with a minimum pavement width of 24 feet, curb, gutter, sidewalk, street light conduit, water and sewer or an Exception shall be obtained. If an Exception is obtained, a copy of the approved Exception shall be submitted with the Development Engineering application: 5. Upon submittal of a Development Engineering Plan application, water plans and analysis prepared by a Registered Professional Engineer shall be submitted for review and approval in accordance with the Infrastructure Design Criteria Manual. The design report shall demonstrate that the water service is adequate to meet estimated domestic flows and required fire flows to support the proposed development. In addition, easements shall be provided as needed; 6. Upon submittal of a Development Engineering Plan application, a sewer design report prepared by a Registered Professional Engineer as per the Infrastructure Design Criteria Manual shall be submitted for review and approval. The design report shall demonstrate that the sanitary sewer capacity is adequate to meet estimated flows and provide sufficient system capacity for this phase of the development and for future development up stream. In addition, easements shall be provided as needed; 7. Upon submittal of a Development Engineering Plan application, a drainage plan report prepared by a Registered Professional Engineer as per the Infrastructure Design Criteria Manual shall be submitted for review and approval. The drainage plan and report shall address storm water quantity control and storm water quality treatment in conformance with the Infrastructure Design Criteria Manual. In addition, easements shall be provided as needed; 8. Prior to submittal of the Development Engineering Plan application, redlined comments shall be addressed. Upon submittal of the Development Engineering Plan application, the redlined comments and the revised drawings and plat per the redline comments shall be submitted for review and approval or an Exception to the Infrastructure Design Criteria Manual or the Standard Specifications for each comment shall be obtained. If any Exception is obtained, a copy of the approved Exception(s) shall be submitted with the Development Engineering Plan application; 9. Prior to Development Engineering Plan approval, engineering reports required for construction approval shall be accepted and agreements required for construction approval shall be executed. In addition, permits required for construction shall be approved and issued and construction plans shall be accepted in accordance with the Infrastructure Design Criteria Manual. All final engineering reports shall be signed and sealed by a Registered Professional Engineer; 10. Prior to approval of the Development Engineering Plan application, a Development Agreement shall be entered into with the City for all public improvements, if applicable: 11. Upon submittal of a Development Engineering Plan application, a cost estimate of the required subdivision improvements shall be submitted for review and approval; 12. Prior to submittal of a Final Plat application, the plat document shall be revised to show Country Road as East Country Road. In addition, the plat title shall be revised to show "dedicated right-of-way in Government Lot 4" as "dedicated right-of-way"; 13. CITY COUNCIL

Mayor's Items

Ron Jeffries provided an update on the Central States Fair/Black Hills Stock Show. He said Ketel Thorstenson provided them with the 2015 audit and it was an ungualified audit. It showed a \$128K profit, and of that amount, \$100K was put back into fair grounds and facilities improvements and maintenance. He said their organization donated \$120K in goods and services to other non-profit agencies in the community. They had an ADA audit and are in the process of making upgrades. He said the Black Hills Stock Show and Rodeo officially runs from January 29, 2016 – February 7, 2016. They start with a ribbon cutting on January 29th. For the first time ever, they had five breeds of cattle sales max out on entries. This is the highest amount of entries they have ever had. The demand and growth of the stock show continue to move forward. They maxed out on the horse sale and had to turn down about 100 entries. They also had to turn down 100 additional vendors because they maxed out on space. One new addition to the stock show is the "Broncs for Breakfast". On January 31, 2016, The South Dakota Auctioneers Association will crown the state champion auctioneer, with some of the proceeds going to the Central States Fair Foundation. The national sheep shearing champion will be crowned at this year's stock show. George Beal has a collection of about 300 saddles and will showcase different saddles and explain the history on them. Jeffries gave the web address, www.Blackhillsstockshow.com, for additional information or to view the full stock show schedule. Motion was made by Weifenbach, second by Estes and carried to Acknowledge, (No. CC011916-04.1) Update on Central States Fair/Black Hills Stock Show. Weifenbach appreciates the efforts of everyone involved in the stock show, especially the volunteers. In response to a question from Drew, Jeffries said they did have to turn away over 100 cattle and horse entries combined, as well as vendors, for not having enough room at the Civic Center. She was sad to hear people had to be turned away and felt more room was necessary to accommodate everyone in the future.
