- 16) PW111516-21 Sidewalk Discussion (Continued from the November 15, 2016, Public Works Committee Meeting) Tech stated that the number one area of concern for sidewalks is Deadwood Avenue. Tech went over the rest of the areas that staff has identified the need for sidewalks. There was discussion on the need for sidewalks and the support of the community. Estes moved, second by Salamun to acknowledge the report. Motion carried unanimously. On consent calendar
- 17) PW112916-14 Funding recommendations for the construction and improvements of Elm Avenue from its current southern terminus near Fieldview Drive for approximately 800 feet. Tech explained the changes to the CIP in order to do the extension of Elm Avenue. There was discussion regarding the concerns about rearranging the CIP projects and the number of WORP's that may exist. Nordstrom moved to fund the extension of Elm Avenue through the CIP. Motion died for lack of a second. Nordstrom made a substitute motion, second by Salamun to send to City Council without recommendation. Motion carried unanimously.
