REFUNDS

Any refunds made will be issued through the library's Business Office or the Circulation Front Desk.

Refunds will be issued for lost and paid materials that are returned with the receipt showing payment for these materials. For refunds over \$50, the refund will be processed through the city billing system, and a check will be mailed to the patron within 45-60 days.

Refunds will be issued for meeting room rental by for-profit groups with seven days prior notice.

Refunds are not issued for non-Pennington County cards, for Friends of the Library merchandise, or for the vending machines.
