# 2012 Funds: Long Term Strategic Planning for Rapid City

In 1992, the City of Rapid City began a process called Vision 2012 - a program of long range planning for the future of our community.

Building on the progress made following the 1972 flood, the City extended the half cent sales tax by a vote of the citizens, to provide a stable funding source to continue the progress and improve the quality of life for our citizens.

### Looking Back: 1972

- On June 9, 1972, heavy rains caused massive flooding of Rapid Creek.
- 238 people lost their lives.
- More than \$100 million in property was destroyed.



#### After the Flood:

The City of Rapid City started a program of civic improvements which included:

- Greenway: Turing the flood plain into a parks system.
- Civic Center.
- Airport Terminal.
- City and School Administration Building.

## 1992: A Long Term Strategic Plan for the Next 20 Years.

#### Community Leaders looked to:

- Move Rapid City forward with a long-term vision.
- Improve the quality of life in Rapid City.
- Make Rapid City a more desirable place to live.
- Provide for the citizens and economic development.

### The question of money:

- A current half-cent sales tax to pay off the debt incurred to build the Civic Center was set to expire in 1995.
- An initiated measure to continue the tax for civic improvements was taken to the people.
- After many meetings between community leaders and the people of Rapid City the initiated measure passes on November 9, 1993.


#### Vision 2012: Phase One -1995
