Rules and Requirements for Mobile Food Vending in Rapid City Parks

Mobile Food Vending is permitted in the following areas (See Attached Map):

- Cambell Street Soccer Field Parking Lot – Adjacent to Cambell Street
- Canyon Lake Park - Beach Drive Parking Lot
- Founders Park Parking Lot – South Half of Lot toward Omaha Street
- Roosevelt Park Parking Lot – Adjacent to Waterloo Street
- Sioux Park – East Parking Lot
- Vickie Powers Park Parking Lot
- West Memorial Park Parking Lot
- Memorial Park Promenade – Push Carts Only. No vehicle access.

The following rules and requirements shall apply to all mobile food vending:

1. Permits are good for the calendar year and can be renewed annually.
2. Hours of operation are between 6:00 am and 9:00 pm.
3. Operations shall not obstruct the visibility of motorists, nor obstruct parking lot circulation or block access to a public street, bike path, or sidewalk.
4. Mobile food vending operations shall obey all parking and traffic laws.
5. Approved permit must be kept with the mobile food vending operation, and provided to City staff and Law Enforcement when requested.
6. Signs must be permanently affixed or painted on the vehicle or structure engaged in the mobile food vending operation. No other signage is permitted.
7. Operators shall be responsible for the storage and daily removal of all trash, refuse, and litter. Such material generated from the mobile food vending operation shall not be deposited in park trash cans, nor bagged and left in the park.
8. Mobile food vending vehicles and push carts shall be removed at the end of each business day.
9. No sale or distribution of alcohol is allowed.
