Attached is an amendment to the 2016 Unified Planning Work Program to carry over the funding to complete the MPO Website and the LiDAR, Orthophotography and Contour Elevation contracts, add \$200,000 for a corridor study in Meade County, as well as add an additional \$100,000 for the I-90 Exit 61 to Exit 67 Corridor Analysis.
