Motion: Move to approve the revised agreement with the Rapid City Society for Genealogical Research as presented.

Background: The original agreement with the Genealogy Society dating from 2005 required updating and a specific term.

The Society and members of library management worked together to draft a revised agreement, which was reviewed by the City Attorney. After review from the Genealogy Society board, representatives then submitted multiple changes, many of which negatively impact the Board's policy making authority, and management's ability to appropriately operate a community-focused public library:

- The Society wanted their collections to be non-circulating. While this is contrary to the majority of the library's collections, use of the genealogy collections is very low, and the library agreed to this request.
- The library had included collection priorities in the agreement, but the Society recommended these priorities be removed. The library agreed to this removal as the community focus which had been outlined in the priorities is referred to several times in the Collection Development policy.
- The Society wanted to determine the location and scope of shelving for their collections; the library must make those determinations based on the collection needs as a whole based on demonstrable community use.
- The Society wanted to be involved in revisions to the collection development policy. Per state law, the Library Board has the authority for determining policy. An unfortunate precedent would be set if an outside party were to develop collection standards that are intended to provide appropriate materials for the entire community.
- The Society wanted the City to insure their materials. For the Society to purchase a rider on the City's policy would likely be significantly more expensive than their own insurance policy; in addition, the deductible on the City's insurance policy is \$50,000. The Society's own insurance should cover their materials wherever they are located.

If the Society and the Library Board cannot agree to the terms of this revised agreement, either party can invoke the termination clause (60-days' written notice) as outlined in the 2005 MOU.

2019 use statistics of all the collections are shown below. In the time since the library was closed due to the Covid-19 pandemic and the Society removed their materials to conduct an inventory, there have been no patron requests to use any of the genealogy materials.
