### **Project Summary Brief**


The applicant has submitted a Rezoning request to change the zoning designation from General Agricultural District to Medium Density Residential District for a peice of land approximately 24.67 acres in size. The applicant has also submitted a Preliminary Subdivision Plan (File #21PL006) for the subject property to create one 24.67 acre lot.

The property is located approximately 2,000 feet southeast of the intersection of N. Creek Drive and N. Valley Drive and is currently void of any structural development. The applicant's Master Plan identifies land on the south side of N. Valley Drive and south of the ridge as appropriate for residential development.

Commission shall consider the fe	ollowing criteria for a request to Rezone:
Criteria	Findings
1. The proposed amendments shall be necessary because of substantially changed or changing conditions of the area and districts affected, or in the city generally.	The applicant has submitted Preliminary Subdivision Plan applications for properties located south and east of the subject property. The proposed construction of streets and utilities in the area is a substantial change supporting the Rezoning request.
2. The proposed amendments shall be consistent with the intent and purposes of this title.	The City's Future Land Use Plan currently identifies the appropriate use of the property as Urban Neighborhood. Urban Neighborhood supports Medium Density Residential District as a primary zoning designation to support a range of medium to high-density housing types. Rezoning the property as proposed will be in compliance with the City's Comprehensive Plan.
3. The proposed amendment shall not adversely affect any other part of the city, nor shall any direct or indirect adverse effects result from the amendment.	The property is located adjacent to N. Valley Drive which will serve as the primary access to the property. N. Valley Drive is identified as a Collector Street on the City's Major Street Plan. Based on the applicant's Master Plan(s) for this property, the proposed Rezoning request is consistent with future development for the area. It does not appear that the amendment will adversely affect any other part of the City.

4. The proposed amendments shall be consistent with and not in conflict with the development plan of Rapid City including any of its elements, major road plan, land use plan, community facilities plan and others.

The proposed Rezoning request is in compliance with the adopted Comprehensive Plan and the City's Major Street Plan.
