#### Project Background:

The proposed First Wesleyan Church will be a great new addition to the City of Rapid City and will be located east of the intersection of East Minnesota Street and Marlin Drive located in the Elks Crossing Subdivision. The proposed Church will have seating for 403 people.

#### **Building Use and Zoning:**

See attached floorplan. The proposed building will have a first floor area of 18,292 SF.

The property is zoned Office Commercial and designated as a Planned Development.

#### **Parking Requirements:**

See attached site layout. Per Rapid City zoning code, a total of 101 parking spaces are required. The proposed site plan provides a total of 101 spaces of which 5 are handicap accessible spaces, meeting the zoning code.

The site and proposed uses are consistent with the assumptions found in the Traffic Impact Analysis prepared for the Elks Crossing Subdivision.

#### Landscaping:

Landscaping has been provided in accordance with the Rapid City Zoning Code.

#### Sanitary Sewer, Water, and Storm Water:

Sanitary Sewer Mains, Water Mains and Storm Water facilities have all been provided to the site. Service line locations are included with the attached site plan.

#### **Building Height:**

The proposed building is one (1) stories and will be no taller than 33' as measured according to RC Code. Current zoning allows for a maximum height of 35' or 3 stories.

#### Lot Coverage:

The combined size of the 2 lots that make up the site will be 4.72 acres or 205,643 SF. The proposed building has a first floor area of 18,292 SF, which equates to a lot coverage of 8.9%. Rapid City zoning code allows for maximum lot coverage of 30%.

#### Signage:

The applicant currently does not have the final design of the monument sign complete. However a future sign location is indicated on the site plan. Upon completion of the monument sign design the applicant will then submit an amendment to the Final Planned Development for the approval of the sign.

#### Lighting:

Site lighting locations have been shown on the site plan and are in accordance with RC Code.

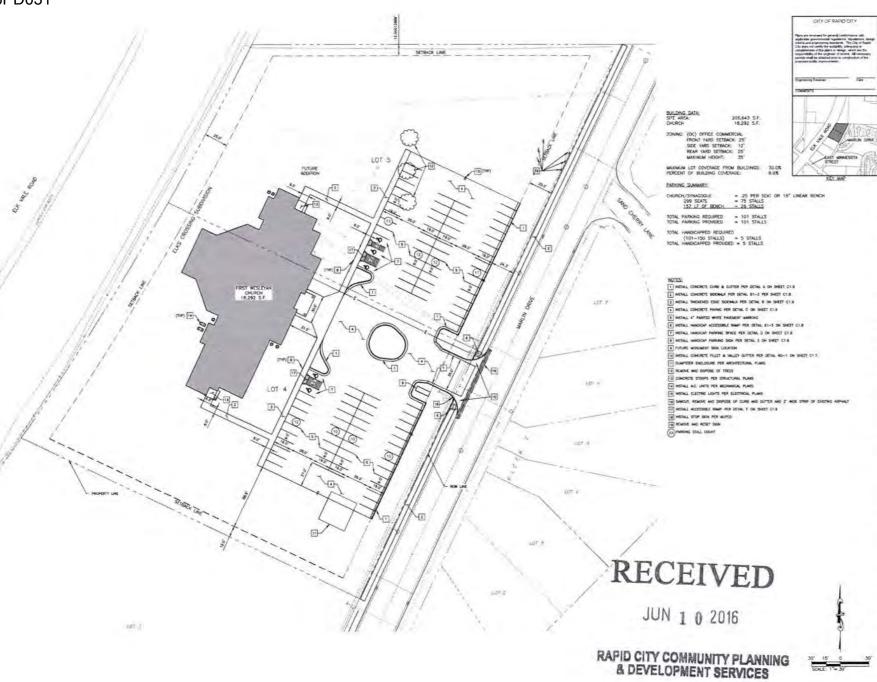
