# **EXAMPLES OF HOW CDBG FUNDS MAY BE USED**

# **Acquisition of Real Property:**

The acquisition of real property in whole or in part by purchase, long-term lease, donation, or otherwise. A permanent interest in the property must be obtained. (Including long term leases for periods of 15 years or more)

### **Eligible Activities**

Cost of property
Cost of surveys, and/or appraisals
Cost of preparation of legal documents
Recordation fees
Other costs necessary to effect the acquisition

### Ineligible Activities

Cost of moveable equipment Furnishings Construction costs for new housing

# Public Facilities and Improvements (excluding "buildings for the general conduct of government")

**Public Facilities -** Facilities operated so as to be open to the general public, such as neighborhood firehouses, public schools, and libraries. Also facilities that are designed for use in providing shelter for persons having special needs are considered to be public facilities (and not permanent housing), and thus are covered under this category of basic eligibility. (i.e. nursing homes, convalescent homes, hospitals, shelters for victims of domestic violence, shelters and transitional facilities/housing for the homeless, halfway houses for run-away children, drug offenders or parolees, group homes for the developmentally disabled and shelters for disaster victims.)

Public Improvements – site improvements of any kind that are made to property that is in public ownership are considered to be a public improvement eligible for assistance under this category. (i.e. streets, sidewalks, curbs and gutters, parks, playgrounds, water and sewer lines, flood and drainage improvements, parking lots, utility lines, and aesthetic amenities on public property such as trees, sculptures, pools of water and fountains, and other works of art.)

Rehabilitation (including removal of architectural barriers to accessibility
Installation of public improvements or facilities

#### Ineligible Activities

Costs of operating or maintaining public facilities or improvements Costs of purchasing construction equipment Costs of furnishings and other personal items such as uniforms New construction of public housing

#### **Public Services**

(CAP = Maximum of 15% of total annual grant amount plus previous years program income – FY 06 Estimated amount available = \$90,750)

Public services must be either a new service or a quantifiable increase in the level of a service, above that which has been provided by, or on behalf, of general local government through funds raised by such unit during the 12 months prior to submission of the applicable Action Plan.(Prevents substitution of CDBG funds for recent support of public services by the grantee using local or State government funding. May be substituted for private or other Federal funds)

Costs of operating and maintaining that portion of a facility in which the service is located.

Ongoing grants or non-emergency payments (defined as more than 3 consecutive months) to individuals for their food, clothing, rent, utilities, or other income payments).
