The Rapid City Metropolitan Planning Organization is requesting an amendment to the Federal Highway Administration Section of the 2017 Unified Planning Work Program to reallocate funding and to include additional work activity within the *Professional Services/Consultant Services* identified in the 2017 Unified Planning Work Program as follows: Professional Services/Consultant Services:

3. Staff will undertake required activities necessary to administer, manage and complete the following projects and studies to the extent of budgeted funding:
 - a. Complete a Metropolitan Planning Organization website
 - b. Complete a feasibility study to create a regional transit service
 - c. Complete the US 16 / US 16B / Catron Blvd intersection study
 - d. Complete the Meade County corridor study between Erickson Ranch Road and 143rd Haines Avenue
 - e. Complete the Interstate corridor study for I-90 between Exit 61-67
 - f. Complete the North Elk Vale Corridor Study
 - g. Complete the traffic analysis and corridor study for Cambell Street from Omaha Street to East North Street.
 - h. Rapid City Railroad Quiet Zone Study
