AMENDMENT TO AGREEMENT BETWEEN THE RAPID CITY PUBLIC LIBRARY BOARD OF TRUSTEES AND S&T SECURITY SERVICES

This Amendment to Agreement is entered into by the Rapid City Public Library Board of Trustees, located at 610 Quincy Street, Rapid City, South Dakota 57701("Board"), and S&T Security Services ("Contractor"), located at 13804 Appaloosa Lane, Rapid City, South Dakota, 57702.

WHEREAS, the Rapid City Public Library Board of Trustees and S&T Security Services, entered into an agreement on April 28, 2017 concerning security services Contractor will provide to Board ("Agreement"); and

WHEREAS, the parties wish to incorporate updated hours for the security service at General Beadle into the Agreement; and

WHEREAS, the parties wish to amend Section 1 of the Agreement to include an additional requirement.

Now, therefore, in consideration of the mutual covenants and agreements contained herein, the parties hereby amend the Agreement as follows:

Section 1 of the Agreement is hereby amended to read in its entirety as follows:

1. The Contractor agrees to provide a uniformed security officer at the Downtown library, at an hourly rate of \$17.50, for the following hours:

Monday through Thursday: 9:00 a.m. through 7:00 p.m.; Friday and Saturday: 9:00 a.m. through 5:00 p.m.; and Sunday: 1:00 p.m. through 5:00 p.m.

The Contractor agrees to provide a uniformed security officer at the North Branch, at an hourly rate of \$17.50, for the following hours:

Monday through Thursday: 3:15 p.m. through 7:15 p.m.;

Friday: 3:15 p.m. through 5:15 p.m.;

Saturday: 9:00 a.m. through 5:15 p.m.; and

Sunday: 1:00 p.m. through 5:15 p.m.

If the library's hours change, the Board will provide written notice at least two weeks in advance to the Contractor, and Contractor agrees to service the changed hours.
