Salamun said it will be nice to have two stations. As the police departments is growing there is need to expand from the central location to the southwest area of the city. Jegeris said the west side location would be south of Jackson, ideally with easy access to Catron Boulevard and Sheridan Lake Road. He was asked to bring the request back in one year at the CIP meeting. He wants this to be a reality in six to ten years. He also mentioned the police department would like to expand to an east location in 10-20 years when there is more expansion and annexation. Salamun noted that Jegeris would be willing to combine with another government agency for the new location in order to save money and resources. Motion passed 8-0.

NON-CONSENT ITEMS – Items 89 – 101

Kyle Treloar, KTM Designs, addressed the council. He said the property they are discussing is near the intersection of Mt. Rushmore Road and Catron Boulevard. The exact intersection is at Les Hollers Way and the future continuation of Promise Road to the north. There is a fire station to the north of Promise Road. They will eventually be constructing Promise Road to the south to tie into the intersection with Les Hollers and Catron Boulevard. He explained there is a center island that separates incoming and outgoing traffic. They are asking for 12-13 feet of lane width instead of the required 20-feet. They would like to match the intersection across the street, which was constructed for the Black Hills Power facility. They are trying to line up the streets running north and south of Catron Boulevard so there is a uniform feel.

Ordinances

Ordinance 6250 (18OA012) An Ordinance Amendment to Adopt Regulations Concerning Mobile Food Vendors by Adopting Provision in Title 17 of the Rapid City Municipal Code. Motion was made by Laurenti, second by Drury and carried that Ordinance 6250 be placed upon its first reading and the title was fully and distinctly read.

Ordinance 6251 (LF050218-10) An Ordinance to Amend Provisions Concerning the Planning Commission by Amending Chapter 2.60 of the Rapid City Municipal Code. Motion was made by Laurenti, second by Lewis and carried to approve Ordinance 6251 be placed upon it first reading and the title was fully and distinctly read.

Ordinance 6248 (LF050218-03) An Ordinance Regarding Supplemental Appropriation #3 for 2018. Motion was made by Laurenti, second by Armstrong and carried to approve Ordinance 6248 be placed upon its first reading and the title was fully and distinctly read.

Ordinance 6247 (LF032818-04) An Ordinance Amending Sections 8.16, 8.28, 10.56, 12.12 and 12.32 of the Rapid City Municipal Code Relating to Nuisances having passed its first reading on April 16, 2018 motion was made by Laurenti, second by Nordstrom that the title be read the second time. Upon vote being taken the following voted AYE: Drew, Nordstrom, Modrick, Salamun, Lewis, Armstrong, Laurenti and Drury; NO: None; whereupon the Mayor declared the motion passed and Ordinance No. 6247 was declared duly passed upon its second reading.

Ordinance 6254 (No. 18RZ012) An Ordinance Amending Section 17.06 of Chapter 17 of the Rapid City Municipal Code, a request by City of Rapid City for a Rezoning from No Use District to General Agricultural District for property generally described as being located 150 feet west of Brooke Street, at the eastern terminus of Nicole Street. Motion was made by Laurenti, second by Salamun and carried that Ordinance 6254 be approved in conjunction with 18AN002 and be placed upon its first reading and the title was fully and distinctly read and second reading set for Monday, May 21, 2018.

Ordinance 6255 (No. 18RZ013) An Ordinance Amending Section 17.06 of Chapter 17 of the Rapid City Municipal Code, a request by KTM Design Solutions, Inc for Dennis Zandstra Real Estate Holdings for a Rezoning from No Use District to Low Density Residential District II for property generally described as

being located south of E. Minnesota Street. Motion was made by Laurenti, second by Drew and carried that Ordinance 6255 be approved in conjunction with 18AN003 and be placed upon its first reading and the title was fully and distinctly read and second reading set for Monday, May 21, 2018.

Ordinance 6258 (No. 18RZ014) An Ordinance Amending Section 17.06 of Chapter 17 of the Rapid City Municipal Code, a request by KTM Design Solutions, Inc. for Dennis Zandstra Real Estate Holdings, LLC for a Rezoning from General Agricultural District to Low Density Residential District II for property generally described as being located south of E. Minnesota Street. Motion was made by Laurenti, second by Modrick and carried that Ordinance 6258 be approved and placed on its first reading and the title was fully and distinctly read and second reading set for Monday, May 21, 2018.

Public Works Committee Items

Drew read in item (PW031318-15) Request funding to construct an approximately 1,400 ft. collector street to provide access to a proposed 175 acre residential subdivision located south of Catron Blvd. and east of Wellington Drive. Estimated cost of \$1,500,000. (This item was continued from the March 19, 2018 City Council Meeting.) Motion was made by Drew, second by Lewis and carried to continue item to the May 21, 2018 city council meeting per the applicant's request.

Drew read in item (PW050118-21) Appeal of Denied Exception Request by North Atlantic Developers, LLC to waive the requirement to install 20-foot wide pavement on both sides of a center street island on Promise Road (City File 18EX040), one Exception denied by staff out of six total Exceptions submitted for the project. Motion was made by Drew, second by Modrick to approve the exception. Salamun stated at the Public Works meeting that Les Hollers Way and Healing Way were built incorrectly as an oversight. He understands that the developer wants the same measurements for continuity on Promise Road. However, the Public Works department would like the correct measurements used instead of continuing the oversight on the Promise Road side. Salamun said an oversight happened but they shouldn't continue the oversight. In response to a question from Salamun, Seals said he sent out a memo describing the complications of safety by allowing the road to be less than 20-feet. As much as Salamun wants it to look good, he wants the road to be safe for traffic. In response to a question from Modrick, Treloar said that public works discovered the exception on Les Hollers Way, late in the design process when they asked for the same exception on Promise Road. Treloar said in order to meet the exception they have removed the median out of the plans in total. In order to meet the 20-foot requirement they had to remove the median. He said they are at a stoplight controlled access point. The island is at a traffic calming benefit and allows them to break up traffic, so north-south vehicles aren't directly interacting with each other. Since the median is removed, there is no barrier between the incoming and outgoing traffic. In response to a question from Modrick, Tech said that someday Les Hollers will be a five-lane arterial road but Promise Road will not. Someday in the future, there will be extra northbound, southbound lanes added there, which will correct the issue. Tech said the inside lanes will always line up with the inside lanes across the road, so there is not a future alignment issue. Tech said there is a signalized intersection on Catron. In response to a question from Laurenti, Tech said KTM bid the project before they had final approved plans from the City of Rapid City. If the exception is not approved then the island won't be built. Seals said the safety issues would be elevated if the island is denied. In response to a question from Nordstrom, Tech said prior to 2012 this criteria was not widely used regarding the width. He said they rely on the design engineers too because they are looking at it as in depth as the city. He said this was missed by two different design professionals as well as city staff on these items. Tech said there is not a lot they can do without significant disruption on the south and west, so it will just be left as is. Nordstrom said he will vote to keep the north side continuous with the south side. He is in favor of granting the exception to keep the consistency. In response to a question from Drury, Tech said the lanes will still line up because the area that was going to have the median will be striped out. Treloar said if the median was built, it would have similar landscaping as the median on the opposite side of the road which is rock. In response to a question from Drury, Young said one of the requirements they are looking at instituting here is that if you are approved for a TIF then you will meet the requirements as they're currently constituted, that no variances or exceptions would be granted.

Drew asked Treloar how everything got moved forward without being approved. Treloar said they submitted their preliminary ideas and they got back a subdivision report. On that report, there were criteria listed that they needed to meet. Some exceptions were made by staff and some weren't. It wasn't until the final plan approval that they found out it would need an exception. Treloar thought it would be approved since the opposite side of the road was approved so he was surprised it wasn't. In response to a question from Lewis, Tech said KTM does not have an approved set of plans submitted, they are waiting on this action tonight. Lewis said it's probably more cost effective for KTM to not do the median. He thinks it's better access for safety vehicles as well. Treloar said they want it for continuity and aesthetics. Motion failed 5-3 with Drew, Nordstrom and Modrick voting in favor of the exception.

Legal & Finance Committee Items

Laurenti read in item (LF050218-08) Approve Authorize Mayor and Finance Officer to Sign Fourth Assignment for Tax Increment District No. 38 Between the City of Rapid City, Heartland Retail Center, LLC, and First Interstate Bank. Motion was made by Nordstrom, second by Modrick to approve. Motion carried 7-1 with Laurenti voting no.

CIP Committee Items

Nordstrom read in item (No. CIP042018-04) Approve Capital Plan for Fire Vehicles. Motion by Nordstrom, second by Drew to approve. Drury said she was the no vote on this item. She thinks fire vehicles should come out of their budget and not out of capital improvements. Mayor said he feels that the fire vehicles shouldn't come out of CIP either. He said he has talked to the Fire Chief about getting them out of CIP as well. He said the issue is that it is about a half a million dollars and in the process of building the 2019 budget, we are hoping to get \$100,000 per year converted from CIP into general fund fire vehicle budget which will put us on a five-year plan to get that money restored to CIP. So there is a plan to get it out of there. Nordstrom said he agrees it's coming out of the wrong line item, but we did not have a plan at the time of this discussion. Drury said that Seals is working on alternate ways to fund it as well. She complimented his initiative. Motion carried 7-1 with Drury voting no.

Community Planning & Development Services Department Items

Motion was made by Drew, second by Modrick and carried to approve (No. 18PL022) A request by KTM Design Solutions, Inc for MDD LLC for a Preliminary Subdivision for proposed Lot 1 of East Haines Subdivision, generally described as being located east of Haines Avenue, adjacent to Kathryn Avenue with the following stipulations: 1. Upon submittal of a Development Engineering Plan application, construction plans for Haines Avenue shall be submitted for review and approval showing the dedication of 4 additional feet of right-of-way and the construction of sewer, sidewalk and a second water main or an Exception shall be obtained.
