#### NON-CONSENT ITEMS - Items 41 - 51

Nancy Hilding, President of Prairie Hills Audobon Society, objects to item (LF073119-04). She spoke of an initiated measure from many years ago regarding this topic. She said there was a compromised in 1996. This has been working for 23 years, just leave things as they are. Julie Anderson, also spoke against the item. She wants non-lethal method used to control deer. Trenton Haffley, with South Dakota Game Fish and Parks, spoke in favor of bow hunting. He stated this program is similar to the one they do in Sioux Falls. Jeff Olson, SD Sportsmen Against Hunger, is in favor of deer management and giving the meat to people who need it.

Tonchi Weaver, spokesperson for South Dakota Citizens for Liberty, spoke on item (LF073119-12). She appreciates council trying to save money. However, she doesn't agree that this is the right away. She is against the proposed ordinance.

#### **Ordinances**

Ordinance 6345 (LF071019-04) an Ordinance to Repeal the Compass Internal Audit Program by Repealing Chapter 2.95 of the Rapid City Municipal Code. Having passed its first reading on July 15, 2019 motion was made by Lewis, second by Modrick that the title be read the second time. Upon vote being taken, the following voted AYE: Drew, Nordstrom, Strommen, Lewis, Armstrong, Drury, Evans, Roberts and Modrick. NO: None; Whereupon, the Mayor declared the motion passed and Ordinance 6345 was declared duly passed upon its second reading.

Ordinance 6347 (LF073119-04) an Ordinance to Amend Section 9.28.020 of the Rapid City Municipal Code Relating to Throwing Stones and Missiles. Mayor explained the current ordinance prohibits throwing or shooting anything inside city limits. Modrick voiced concern. She wants to look at previous initiated measure. Evans and Armstrong are also opposed. Haffley explained there would be three designated areas to bow hunt and they would model their program after the program that the City of Sioux Falls has. In response to a question from Armstrong, Biegler said that non-lethal methods such as trapping or relocating are not realistic or cost effective. Motion to approved was made by Lewis, second by Robert that Ordinance 6347 be placed upon its first reading that the title was fully and distinctly read. Motion carried 6 to 3 with Modrick, Evans and Armstrong voting no. Second reading set for Monday, August 19, 2019.

Ordinance 6352 (LF073119-12) an Ordinance Removing the Requirement to have a Runoff Election for Municipal Offices by Repealing Section 1.16.030 of the Rapid City Municipal Code. Mayor explained state statute and the council can decide if they want to follow the same rule. Motion was made by Lewis, second by Drew to approve. Armstrong stated that eliminating the run-off encourages people to vote once. Drew said a run-off election costs extra money and it's emotionally hard for the candidates to keep campaigning and waiting for the outcome. Roberts stated run-offs shouldn't be easy. He is opposed to the ordinance. Motion carried 8-1 with Roberts voting no.

Ordinance 6342 (No. 19RZ022) an Ordinance Amending Section 17.06 of Chapter 17 of the Rapid City Municipal Code, a request by Dream Design International, Inc. for Eileen and Edward Eller for a Rezoning Request from General Agricultural District to Low Density Residential District for property generally described as being located west of the current terminus of W. Minnesota Street, east of Mt. Rushmore Road. Motion was made by Modrick, second by Roberts and carried that Ordinance 6342 be placed upon its first reading and the title was fully and distinctly read and second reading set for Monday, August 19, 2019.

Ordinance 6343 (No. 19RZ023) an Ordinance Amending Section 17.06 of Chapter 17 of the Rapid City Municipal Code, a request by Brian Watland for Western Dakota Technical College for a Rezoning Request from Low Density Residential District to Public District for property generally described as being located east of Mickelson Drive, west of Valle Drive and north of Homestead Street. Motion was made by Nordstrom, second by Drury and carried that Ordinance 6343 be placed upon its first reading and the title was fully and distinctly read and second reading set for Monday, August 19, 2019.

Ordinance 6344 (No. 19RZ024) an Ordinance Amending Section 17.06 of Chapter 17 of the Rapid City Municipal Code, a request by Dream Design International, Inc. for Yasmeen Dream, LLC for a Rezoning Request from General Agricultural District to Medium Density Residential District for property generally described as being located east of Elk Vale Road. Motion was made by Drew, second by Nordstrom and carried that Ordinance 6344 be placed upon its first reading and the title was fully and distinctly read and second reading set for Monday, August 19, 2019.

Roberts read in item (PW073019-01) Authorize staff to Advertise for Bids Project No. 2491 / CIP No. 51225 City Hall Administration Center Renovation. Motion was made by Roberts, second by Lewis to approve. Motion carried 8-1 with Evans voting no.

## **Community Development Items**

Mayor read in item (No. 19PL042) - A request by Fisk Land Surveying & Consulting Engineers, Inc. for Magheramore, LLC for a Preliminary Subdivision Plan for proposed Lots 1 to 23 of Darlington Estates Subdivision No. 2, generally described as being located at the current southern terminus of Kimberwick Road. Motion was made by Drew, second by Drury and carried to approve with the following stipulations: 1. Upon submittal of a Development Engineering application, construction plans for Kimberwick Road, a local street, shall be submitted for review and approval showing the street located in a minimum 52-foot wide right-of-way and constructed pursuant to Figure 2-1 of the Infrastructure Design Criteria Manual with dry sewer and water mains designed and constructed pursuant to Figure 3-1 or the approval of an Exception shall be required. If an Exception is obtained, a copy of the approved document shall be submitted with the Development Engineering Plan application; 2. Upon submittal of a Development Engineering application, construction plans for Darlington Court, Kimberwich Court and Magheramore Court, lane place streets, shall be submitted for review and approval showing the street(s) located in a minimum 50-foot wide right-of-way and constructed pursuant to Figure 2-1 of the Infrastructure Design Criteria Manual with dry sewer and water mains designed and constructed pursuant to Figure 3-1 or the approval of an Exception shall be required. In addition, the cul-de-sac bulb shall be constructed pursuant to Figure 2.13 of the Infrastructure Design Criteria Manual or an Exception shall be required. If Exception(s) are obtained, a copy of the approved document(s) shall be submitted with the Development Engineering Plan application; 3. Prior to submittal of a Development Engineering Plan application, construction plans for each of the proposed streets shall be submitted for review and approval showing the construction of sidewalk as a subdivision improvement or a Variance shall be required from the City Council; 4. Prior to approval of the Development Engineering Plan application, engineering reports required for construction approval shall be accepted and agreements required for construction approval shall be executed. In addition, permits required for construction shall be approved and issued and construction plans shall be accepted in accordance with the Infrastructure Design Criteria Manual. All final engineering reports shall be signed and sealed by a Professional Engineer and contain a Certification Statement of Conformance with City Standards, as required by the Infrastructure Design Criteria Manual; 5. Upon submittal of a Development Engineering Plan application, water plans and analysis prepared by a Registered Professional Engineer shall be submitted for review and approval in accordance with the Infrastructure Design Criteria Manual. The design report shall demonstrate that the water service is adequate to meet estimated domestic flows and required fire flows to support the proposed development. If determined that domestic flows and required fire flows cannot be provided. then a Covenant Agreement shall be submitted for recording with the Final Plat application stating that fire sprinkler protection shall be provided in all new residential structures or an Exception shall be required. If an Exception is obtained, a copy of the approved document shall be submitted with the Development Engineering Plan application; 6. Upon submittal of a Development Engineering Plan application, soils data for the proposed lots demonstrating that the soils are suitable for on-site wastewater treatment systems shall be submitted for review and approval; 7. Upon submittal of a Development Engineering Plan application, a drainage plan and report prepared by a Registered Professional Engineer as per the Infrastructure Design Criteria Manual and the Rapid City Municipal Code shall be submitted for review and approval for the proposed subdivision improvements. The drainage plan shall evaluate existing drainage including but not limited to the capacity of existing drainage, dam, pond and railroad culvert crossing. The drainage report shall also address storm water quantity control and storm water quality treatment. In addition, easements shall be dedicated as needed; 8. Upon submittal of a Development Engineering Plan application, an Erosion and Sediment Control Plan in compliance with the adopted Stormwater Quality Manual and the Infrastructure Design Criteria Manual shall be submitted for review and approval if subdivision improvements are required; 9. Upon submittal of

a Development Engineering Plan application, a cost estimate for any required subdivision improvements shall be submitted for review and approval; 10. Prior to approval of the Development Engineering Plan application, a Development Agreement shall be entered into with the City for all public improvements; 11. Prior to submittal of a Final Plat application, an alternate street name for Kimberwick Court shall be submitted to the Emergency Services Communication Center for review and approval. In addition, the approved street name shall be shown on the Final Plat document; 12. Prior to submittal of a Final Plat application, the applicant shall submit proof of the legal entity which will provide the mechanism for street maintenance and snow removal; 13. Upon submittal of a Final Plat application, an agreement shall be submitted for recording securing ownership and maintenance of any proposed drainage elements. In addition, Major Drainage Easements shall be dedicated for the proposed drainage improvements; 14. Upon submittal of a Final Plat application, surety for any required subdivision improvements that have not been completed shall be posted and the subdivision inspection fees shall be paid; and, 15. Prior to the City's acceptance of the public improvements, a warranty surety shall be submitted for review and approval as required.

Mayor read in item (No. 19PL049) A request by Dream Design International, Inc. for Eileen and Edward Eller for a Preliminary Subdivision Plan for proposed Lots 1 thru 37 of Block 1 of Scotland Hills Subdivision, generally described as being located west of the current terminus of W. Minnesota Street, east of Mt. Rushmore Road. Motion was made by Modrick, second by Armstrong and carried to approve with the following stipulations: 1. Prior to submittal of a Development Engineering application, the applicant shall continue to coordinate the design of the water system with City staff to ensure that City criteria and design standards are being met; 2. Prior to approval of the Development Engineering Plan application, engineering reports required for construction approval shall be accepted and agreements required for construction approval shall be executed. In addition, permits required for construction shall be approved and issued and construction plans shall be accepted in accordance with the Infrastructure Design Criteria Manual. All final engineering reports shall be signed and sealed by a Professional Engineer and contain a Certification Statement of Conformance with City Standards, as required by the Infrastructure Design Criteria Manual; 3. Upon submittal of a Development Engineering Plan application, construction plans for W. Minnesota Street shall be submitted for review and approval showing the street located in a minimum 52-foot wide right-of-way and constructed pursuant to Figure 2-1 of the Infrastructure Design Criteria Manual or the approval of an Exception shall be required. In addition, the cul-de-sac bulbs shall be constructed pursuant to Figure 2.13 and the turnarounds with islands shall be constructed pursuant to Section 2.20.1(2) of the Infrastructure Design Criteria Manual or an Exception shall be required. If Exception(s) are obtained, a copy of the approved document(s) shall be submitted with the Development Engineering Plan application; 4. Upon submittal of a Development Engineering Plan application, water plans and analysis prepared by a Registered Professional Engineer shall be submitted for review and approval in accordance with the Infrastructure Design Criteria Manual. The design report shall demonstrate that the water service is adequate to meet estimated domestic flows and required fire flows to support the proposed development. In addition, easements shall be provided as needed; 5. Upon submittal of a Development Engineering Plan application, a sewer design report prepared by a Registered Professional Engineer as per the Infrastructure Design Criteria Manual shall be submitted for review and approval. The design report shall demonstrate that the sanitary sewer capacity is adequate to meet estimated flows and provide sufficient system capacity in conformance with the Infrastructure Design Criteria Manual. In addition, easements shall be provided as needed; 6. Upon submittal of a Development Engineering Plan application, a drainage plan and report prepared by a Registered Professional Engineer as per the Infrastructure Design Criteria Manual and the Rapid City Municipal Code shall be submitted for review and approval for the proposed subdivision improvements. The drainage report shall address storm water quantity control and storm water quality treatment. In addition, easements shall be dedicated as needed; 7. Upon submittal of a Development Engineering Plan application, an Erosion and Sediment Control Plan in compliance with the adopted Stormwater Quality Manual and the Infrastructure Design Criteria Manual shall be submitted for review and approval if subdivision improvements are required; 8. Upon submittal of a Development Engineering Plan application, a cost estimate for any required subdivision improvements shall be submitted for review and

approval; 9. Prior to approval of the Development Engineering Plan application, a Development Agreement shall be entered into with the City for all public improvements; 10. Prior to submittal of a Final Plat application, the property shall be rezoned from General Agriculture District to Low Density Residential District; 11. Prior to submittal of a Final Plat application, the plat document shall be revised to show W. Minnesota Road as W. Minnesota Street; 12. Prior to submittal of a Final Plat application, a Wild Land Fire Mitigation Plan shall be entered into with the Fire Department; 13. Upon submittal of a Final Plat application, a Covenant Agreement shall be submitted for recording securing fire sprinkler protection for all lots and that acceptable building materials and vegetation as per the Rapid City Wildland Urban Interface Standards shall be utilized as per approved Exception 19EX089; 14. Upon submittal of a Final Plat application, a Covenant Agreement shall be submitted for recording securing maintenance of the proposed landscape islands within the street right-of-way; 15. Upon submittal of a Final Plat application, an agreement shall be submitted for recording securing ownership and maintenance of any proposed drainage elements. In addition, Major Drainage Easements shall be dedicated for the proposed drainage improvements: 16. Upon submittal of a Final Plat application, surety for any required subdivision improvements that have not been completed shall be posted and the subdivision inspection fees shall be paid; and, 17. Prior to the City's acceptance of the public improvements, a warranty surety shall be submitted for review and approval as required.

Mayor read in item (No. 19PL052) A request by Davis Engineering, Inc. for Reub Family Trust for a Preliminary Subdivision Plan for proposed Lots 8A and 8B of Hills View Subdivision, generally described as being located at 1171 Valley Drive. Motion was made by Lewis, second by Drury and carried to approve with the following stipulations: 1. Prior to submittal of a Final Plat application, the approval of an Exception is required to allow 94 dwelling units with one point of access in lieu of a maximum of 40 dwelling units as per Section 2.6 of the Infrastructure Design Criteria Manual: 2. Prior to submittal of a Final Plat application, the plat document shall be revised to show the dedication of five additional feet of right-of-way along Hillside Drive or the approval of an Exception is required. If an Exception is obtained, a copy of the Exception shall be submitted with the Final Plat application; 3. Prior to submittal of a Final Plat application, the plat document shall be revised to show the dedication of 34-feet of right-of-way from the center of the section line highway along Valley Drive or the approval of an Exception is required. If an Exception is obtained, a copy of the Exception shall be submitted with the Final Plat application; and, 4. Prior to submittal of a Final Plat application, the plat document shall be revised to address comments from the Register of Deed's Office as follows: a) The plat title shall be revised to read Lot 8 of Hills View Subdivision in the "formerly" description; b) A signature line shall be added for the notary of the owner acknowledgment to sign; and, c) The notary acknowledgment for the owners shall read "trustees of the trust".
