17) PW042616-12 - Appeal of Onsite Wastewater Disposal and Treatment Permit per Ordinance 13.20 - Kurt Anderson. Dr. Kurt Anderson - 8855 Clarkson Road, stated he received a notice to permit his septic system that he has lived on 65 acres since 1998

and has met all county requirements and wants to know how the City can require this permit. Dr. Anderson also said that all water from his property flows to the south. George Ferebee was present as a District 1 County Commissioner to represent Dr. Anderson and would like the County and City to get together and talk about the jurisdiction of the 1-mile area. Nyberg stated that the city ordinance and state law allow that we have jurisdiction over the 1-mile area. Weifenbach stated that septic systems have to be inspected and permitted in both the city and county. Anderson stated that he has never had his septic system permitted and was not aware that the county has the same program. Estes moved, second by Weifenbach to deny the appeal and require Dr. Kurt Anderson to permit his septic system at 8855 Clarkson Road. Motion carried unanimously. *On consent calendar*
