R Johnson advised that the current timeline is built to accommodate the baseball season, scheduled to end July 15, and complete the project before the season opens again May 1, 2021 so a delay at this point will essentially be a one year delay on starting the project. Roberts stated that moving forward on this project would provide a positive economic opportunity for the community and questioned reviewing only this Vision Project without looking at the other projects which were also funded in the last round. R Johnson clarified that this project uses funds from both the Vision Funds and Capital Improvement funds. Armstrong stated that she is not proposing to cancel the project, but urged members to consider if a delay was prudent while facing the current budgetary uncertainties. Authorize Staff to Advertise for Bids Project No. 2508 / CIP No. 51231 Fitzgerald Stadium Renovation, estimate cost of \$4,100,000.00
