

**AMENDMENT TO SUBRECIPIENT CONTRACT FOR  
COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) FUNDING  
ENTITLEMENT FUNDS CFDA# 14.218**

WHEREAS, the City of Rapid City ("City/Grantee,") and Behavior Management Systems, Inc., ("Subrecipient,") entered into a Subrecipient Contract for Community Development Block Grant (CDBG) Funding Entitlement Funds CFDA# 14.218 (Subrecipient Contract) on May 10, 2019; and

WHEREAS, the City/Grantee has, under date of April 1, 2019 entered into a Funding Approval/Agreement with the U.S. Department of Housing & Urban Development providing for financial aid to the City under Title I of the Housing and Community Development Act of 1974 Public Law 93-383, as amended, for Community Development Block Grant (CDBG) entitlement funds CFDA # 14.218; and

WHEREAS, this Subrecipient Contract was subject to City/Grantee's receipt of the U.S. Department of Housing & Urban Development Community Development Block Grant funds and the requirement that City/Grantee conform with federal guidelines for the use of such Grant funds; and

WHEREAS, the City/Grantee has certified actual receipts compared to estimated receipts for FY18 and FY19, such that the City/Grantee must make an amendment in funding to the Subrecipient Contract in order to conform with federal guidelines; and

WHEREAS, the funding for the Subrecipient Contract must be reduced from the \$46,800 stated in the Subrecipient Contract to \$37,600.

NOW, THEREFORE, the City/Grantee and the Subrecipient hereby agree to amend the Subrecipient Contract as follows:

The funding stated in the Subrecipient Contract is reduced from Forty-Six Thousand Eight Hundred Dollars (\$46,800.00) to Thirty-Seven Thousand Six Hundred Dollars (\$37,600.00). Any reference to Forty-Six Thousand Eight Hundred Dollars (\$46,800.00) shall be changed to Thirty-Seven Thousand Six Hundred Dollars (\$37,600.00).
