- 12) PW051016-08 Estes moved, second by Roberts to Deny the Appeal of Onsite Wastewater Disposal and Treatment Permit per Ordinance 13.20 Ted Schamber. Schamber explained that water does not run uphill and his property will not pollute the Rapid City water supply. Tech explained the reason for the septic ordinance and the need for a permit. Landeen explained that the City and County have the same septic regulations that protect the water for both entities. There was discussion on the City and County regulations. Motion carried unanimously. On consent calendar
- 13) PW051016-09 Traffic on West Boulevard West Boulevard Homeowners. Allison Hanson from 1013 West Boulevard, was present to voice concerns about traffic issues on West Boulevard resulting from the construction on Mount Rushmore Road and asked that additional temporary stop signs be installed to slow the traffic. Tech stated that the West Boulevard Homeowner's Association voted to not add additional temporary stop signs on West Boulevard. The Police Department said that they have been watching the area. Wright moved, second by Weifenbach to acknowledge the discussion. Motion carried unanimously. On consent calendar
- 14) PW051016-10 Discuss a WORP on Dyess Avenue Bill Freytag. Freytag explained the reason for wanting the exception and not having to sign a WORP to build the road. Landeen explained the situations where this will affect future development of arterial streets. There was discussion on the development of future streets and utilities. Estes moved, second by Roberts to acknowledge the discussion. Motion carried unanimously. *On consent calendar*
