When individuals enter the shop, we do our best to make them feel welcome and would love to be able to offer the comforts that we would be able to provide them if they came to our home. We are hoping to offer patrons the opportunity to kick back and enhance their experience by enjoying a cold beer or glass of wine if that will help them unwind from a long day and/or increase their social experience. For the purposes of this intention, the following outlines details of this request:

- (1) A valid South Dakota beer/wine license or permit will be obtained by Black Hills Barbershop.
- (2) Patrons wishing to purchase alcohol must be 21 and provide proof of ID at the time of purchase.
- (3) Beer and wine will cost patrons an extra charge of \$3-\$5 per beverage.
- (4) No more than 16 ounces of beer/wine will be offered to a client.
- (5) The beer and wine will only be provided during the following normal business hours:  
 Sunday- Closed  
 Monday-Closed  
 Tuesday- 12:00pm-8:00pm  
 Wednesday- 10:00am- 6:00pm  
 Thursday- 11:00am-7:00pm  
 Friday- 10:00am-3:00pm  
 Saturday- 9:00am- 4:00pm
