  - REVISIONS GENERALLY INCLUDE RELOCATION OF DEFINITIONS, CLARIFICATION OF WORDING, REMOVAL OF FEES, MODIFICATION OF PERMITTING PROCESS AND REFLECT CURRENT PRACTICES AND POLICIES

## CHAPTER 8.08 – SOLID WASTE


- CLARIFIES THAT THE UTILITY RATE RELIEF PROGRAM MAY BE APPLIED TO CITY SOLID WASTE CHARGES AND IS AVAILABLE TO INDIVIDUALS WHO HAVE SOLID WASTE ONLY SERVICES

# CHAPTER 13.04 – GENERAL PROVISIONS

- INCORPORATE DEFINITIONS FROM CHAPTER 13.08 INTO CHAPTER 13.04
- REMOVED FEES ALREADY CONTAINED IN THE SEMI-ANNUAL FEE RESOLUTION; THERE ARE NO PROPOSED ADJUSTMENTS TO EXISTING FEES OR RATES
- CONSOLIDATED LANGUAGE
- CONSOLIDATED MULTIPLE PERMITS UNDER THE RIGHT TO WORK PERMIT



# CHAPTER 13.08 – WATER SERVICE SYSTEM

- MOVED DEFINITIONS FROM CHAPTER 13.08 TO CHAPTER 13.04
  - CLARIFY THE PERMITTING PROCEDURES FOR CONNECTING AND TAPPING INTO THE CITY WATER SYSTEM
  - CLARIFY AND UPDATE THE REQUIREMENTS FOR TAKING OF WATER FROM A FIRE HYDRANT
  - CLARIFY REGULATIONS REGARDING WATER SERVICE CONFIGURATIONS AND WATER METER PLACEMENT
  - REQUIRE PROPERTY OWNERS TO OPEN UTILITY ACCOUNTS
  - UPDATE AND CLARIFY THE UTILITY RATE RELIEF PROGRAM
  - REMOVED FEES ALREADY CONTAINED IN THE SEMI-ANNUAL FEE RESOLUTION; THERE ARE NO PROPOSED ADJUSTMENTS TO EXISTING FEES OR RATES

## CHAPTER 13.16 – SEWER SERVICE SYSTEM

- CLARIFY THAT VIOLATIONS OF THE CITY SEWER REGULATIONS MAY BE DEEMED A NUISANCE
- CLARIFY THE PERMITTING PROCEDURES FOR CONNECTING AND TAPPING INTO THE CITY SEWER SYSTEM
- REQUIRE PROPERTY OWNERS TO OPEN UTILITY ACCOUNTS
- CLARIFY APPLICATION OF THE INDUSTRIAL WASTE PROGRAM APPEAL PROCESS
- CLARIFY THE REQUIREMENTS FOR LICENSURE AND OVERSIGHT OF LIQUID WASTE HAULERS
- REMOVED FEES ALREADY CONTAINED IN THE SEMI-ANNUAL FEE RESOLUTION; THERE ARE NO PROPOSED ADJUSTMENTS TO EXISTING FEES OR RATES
