Pursuant to due call and notice thereof, a Special meeting of the City Council of the City of Rapid City was held at the City/School Administration Center in Rapid City, South Dakota on Tuesday, June 14, 2016 at 12:15 P.M.

Roberts, Amanda Scott and Ron Weifenbach; and the following Alderpersons arrived during the course of the meeting: None; and the following were absent: Steve Laurenti, Brad Estes and Jerry Wright.

3. Jason Salamun, having received a majority of all votes cast for the office of Alderman for the Third Ward for a term of three years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Third Ward and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

4. Amanda Scott, having been unopposed as candidate for the office of Alderman for the Fourth Ward, for a term of three years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Fourth Ward, and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

5. Darla Drew, having received a majority of all votes cast for the office of Alderman for the Fifth Ward for a term of three years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Fifth Ward and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

BE IT FURTHER RESOLVED that this resolution is found and determined to be necessary for the immediate preservation of the public peace, health, and safety, and for the support of the municipal government and its existing public institutions, wherefore an emergency exists and this resolution shall take effect immediately upon its passage and publication according to law.
