Pursuant to due call and notice thereof, a regular meeting of the City Council of the City of Rapid City was held at City Hall, Council Chambers, 300 Sixth Street, in Rapid City, South Dakota on Monday, June 6, 2022, at 6:30 P.M.

The following members were present: Mayor Steve Allender and the following Alderpersons: Greg Strommen, Jason Salamun, Ritchie Nordstrom, Ron Weifenbach, Pat Jones, Bill Evans, Laura Armstrong, Darla Drew, John Roberts and Lance Lehmann; the following were absent: None; the following Alderpersons arrived during the course of the meeting: None.

ADOPTION OF AGENDA

Motion was made by Jones, second by Lehmann and carried 10-0 to adopt the agenda.

SPECIAL GUEST SPEAKER

Mayor Don Barnett spoke on the 50th Anniversary of the 1972 Flood. He also spoke on elections and supporting each during this time.

GENERAL PUBLIC COMMENT

Michael Piegza spoke to the council regarding Kingsbury Associates. He indicated it was a meat packing plant that was looking to locate to Rapid City in 2023. He is opposed to this business locating here.

Chuck Henrie apologized to Rapid City Fire and Rapid City PD for speaking harshly about helping him during the incident he spoke of at the May 16, 2022 city council meeting. He understands they have protocol to follow. He spoke about circumstances during the 1972 Flood and helping people during that time.

Motion was made by Weifenbach, second by Roberts and carried 10-0 to approve.

Mayor Allender read in item (LF060122-10) Authorize Staff to Apply for and Accept if Awarded the FY22 Office of Justice Programs Community Based Violence Intervention and Prevention Initiative Grant in the Amount of \$2,000,000. Salamun asked Asst. Police Chief Sitts about the grant. Sitts indicated there are no strings and no city match. This is for the addition of three people to the Journey On program. It is not for gun control or criminals/victims. Motion was made by Lehmann, second by Strommen to approve. Armstrong asked to abstain. Motion carried 9-0 with Armstrong abstaining.

Mayor Allender read in item (LF060122-11) Authorize the Mayor and Finance Director to Sign Great Plains Co-Response Services Contract in the Amount of up to \$114,000 in a Calendar Year. Motion was made by Jones, second by Nordstrom to approve. Fire Chief Culberson said this is independent from Journey On. This service contract is designed to add a case manager from Great Plains Tribal Leader's Health Board to work with Journey-On and co-response efforts in Rapid City. Armstrong asked to abstain. Motion carried 9-0 with Armstrong abstaining.

Mayor Allender read in item (LF060122-12) Authorize the Mayor and Finance Director to Sign Journey-On Co-Response Services Contract in the Amount of \$113,360.00. Motion was made by Jones, second by Salamun to approve. This service contract is designed to add a Director of Operations for Journey-On to enhance co-response efforts in Rapid City. The contractor agrees to provide oversight and administration of team outreach activities. They agree to provide outreach, assessment, mentoring, case management, and transportation services to the houseless community throughout the city limits of Rapid City. Lehmann and Armstrong asked to abstain. Motion carried 8-0 with Lehmann and Armstrong abstaining.

Mayor Allender read in item (LF060122-16) Approve to Allow City Council Members and their Beneficiaries to be Included on the City's Health Insurance Plan. Stroot said this benefit would start on July 1, 2022. The estimated cost for ten members would be approximately \$105K annually. This has not been implemented before and not all members will be taking the benefits, so the number could be different. The benefit is optional. Armstrong voiced opposition. Motion was made by Salamun, second by Weifenbach to approve. Motion carried 9-1 with Armstrong voting no. Sumption asked for a funding source. Motion was made by Lehmann, second by Roberts to move money from the Council Contingency Fund to the Health Insurance line item within the Council's organizational budget code. Armstrong said she doesn't like that this is taking place in the middle of a budget. Mayor Allender said they would wait to see how many enroll and the cost of enrollment and transfer the needed funds when they know that number. This is for 2022. Next year for 2023, this item could be budgeted separately. Motion to approve funding source carried 9 to 1 with Armstrong voting no.

Upon vote being taken, the following voted AYE: Weifenbach, Lewis, Drew, Nordstrom, Strommen, Evans, Lehmann, Armstrong, Salamun and Jones and; NO: None; whereupon the Mayor declared the motion passed and Ordinance No. 6539 was declared duly passed upon its second reading.

Motion was made by Salamun, second by Jones to approve. Stroot said this is a 6-9-month process. Gallagher expects the study to be completed by November 2022. Gallagher comes up with a pay scale and it's up to the council to examine and adopt if they want. City Directors have talked about rotating the wage study between the four different unions with no wage study being done every fifth year. That was just an idea the Directors talked about. Nordstrom said the wage is not about an individual, it's about the position. Motion carried 10-0.
