

**MEMORANDUM OF UNDERSTANDING
AND INTERAGENCY AGREEMENT**

CARE CAMPUS COORDINATION MEETING

PURPOSE. The purpose of this document is to establish a Memorandum of Understanding (MOU) between various entities (**Pennington County Sheriff's Office, Pennington County Human Services, Rapid City Police Department Quality of Life Unit, Behavior Management Systems, Great Plains Tribal Leaders Health Board, Rapid City Fire Department/Mobile Medic, Monument Health, Volunteers of America, Community Health Center of the Black Hills, Journey On, One Heart, Cornerstone Rescue Mission, Hope Center, City of Rapid City, Department of Social Services,** _____, _____, _____, _____) involved in the Care Campus Coordination Meeting regarding Care Campus clients and services. This MOU shall define the responsibilities of each of the undersigned agencies as it relates to confidentiality of information shared at Care Campus Coordination Meetings.

GOALS AND OBJECTIVES. The goal of the Care Campus Coordination Meeting is to coordinate services for the clients. This includes, but is not limited to, sharing information about police contact with clients and details of case management. While many clients sign release of information to allow for sharing of information between agencies, there are also opportunities to discuss individuals in the community that may soon need to access services. It is in the best interest of the community and these individuals if involved agencies can discuss coordination of services and details, in an effort to streamline services through all partner agencies.

CONFIDENTIALITY. It is the responsibility of each undersigned agency to keep all information shared during a Care Campus Coordination Meeting confidential. All agencies agree to keep all client information confidential and secure in compliance with all applicable laws, including HIPAA, and not to divulge any protected and confidential information to any third parties, in any way except as may be compelled by federal, state or tribal court orders and subject to court rules on confidentiality.

DURATION. This MOU shall remain in effect as long as it is beneficial to Care Campus clients to hold a Care Campus Coordination Meeting. It may be amended or subject to update as necessary to obtain appropriate agency signatures or to address any relevant issues.

ACCEPTANCE. The signatures below indicate agreements by the listed agencies to facilitate coordination and streamlining of services for Care Campus clients, and a commitment to confidentiality as outlined in this MOU.
