

**EMERGENCY RESOLUTION CANVASSING VOTE FOR THE ANNUAL
MUNICIPAL ELECTION HELD JUNE 4, 2019 – FIFTH WARD**

WHEREAS there was held in the City of Rapid City, South Dakota, on Tuesday, the 4th day of June, 2019, the Annual Municipal Election of the City of Rapid City, South Dakota, for the purpose of electing a Mayor and five Alderpersons of said City; and

WHEREAS the results of the Annual Municipal Election for Ward 5 Alderman have been presented to the Common Council for purposes of canvassing the election returns.

NOW, THEREFORE, BE IT RESOLVED by the City of Rapid City that the Official Canvass Sheet, attached hereto and incorporated herein by this reference, is approved by the Common Council in its capacity as the Board of Canvassers for the City of Rapid City.

BE IT FURTHER RESOLVED that Darla Drew, having received a majority of all votes cast for the office of Alderman for the Fifth Ward for a term of three years, is hereby declared to be duly elected to the office of Alderman of the City of Rapid City for the Fifth Ward and for the term as hereinabove set forth, and is entitled to qualify for and hold said office as provided by law.

BE IT FURTHER RESOLVED that this resolution is found and determined to be necessary for the immediate preservation of the public peace, health, and safety, and for the support of the municipal government and its existing public institutions, wherefore an emergency exists and this resolution shall take effect immediately upon its passage and publication according to law.


