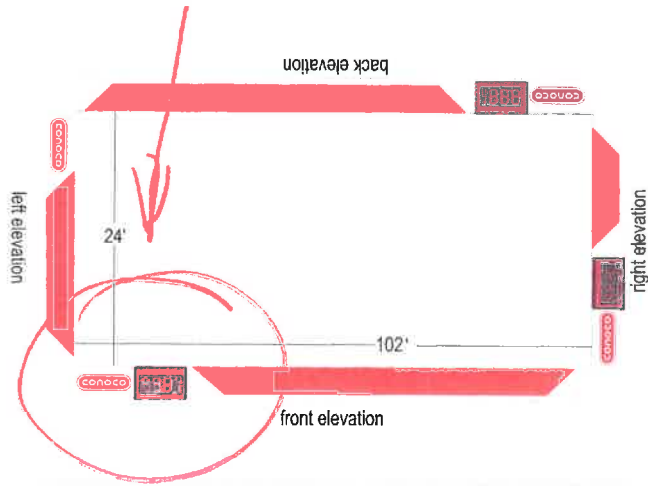
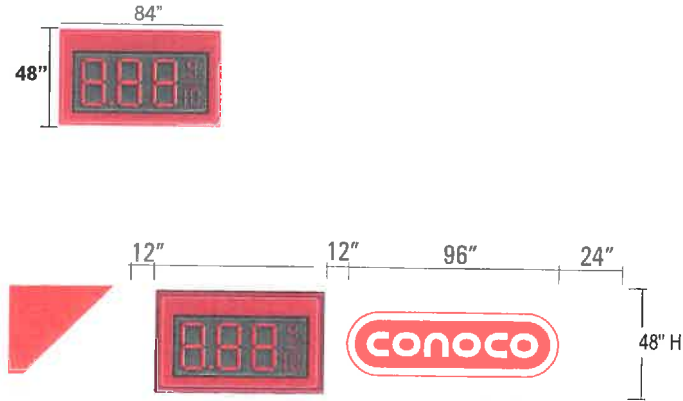

CANOPY DETAIL

Work to be Performed on CANOPY 1 of 1

Remove all Existing Signage.

- A Canopy Fascia**
 - Install new ACM Panels - Oasis Image
 - Install new ACM Panels - Muted Image (with approved exception)
 - Paint existing canopy surface - Muted Image (with approved exception)
- B Fascia Height**
 - 36" Fascia Height
 - 48" Fascia Height
- C Canopy Corners**
 - Square
 - Rounded (Logo placed 12" from tangent of curve)
 - Other non-right angles
- D Illuminated Logos**
 - 36" Logo (33" x 33")
 - 48" Logo (45" x 45")
- E Canopy Columns**
 - Oasis red paint starting from bottom of column to match the height of adjacent dispenser skirt or to 30", whichever comes first.
 - Oasis silver band 3" decal above the red.
 - Columns on raised island end caps are 100% white (no red or silver).

* Columns that are unpainted brick or natural stone will be excused from the Oasis color image and do not require an exception.
- F Canopy Clearance Decals**
 - Measure height clearance and round down to nearest 6".
 - Install on sides of the canopy that have incoming traffic: 1 or 2 decals per side for short canopies; Use 3 decals per side for long canopies.
 - Install black decal on the white portion of fascia below the silver stripe, centered vertically.

* May not be installed on the white logo panel.
- G Fuel Position Numbers**
 - Flag signs mounted on Canopy Poles.
- H Bollards**
 - Paint Bollards Oasis Red
 - Unpainted Stainless Steel
- I Fuel Islands**
 - Paint island curbs Oasis Silver
 - Paint island curbs Charcoal
 - Optional: Paint horizontal island surface Oasis Silver

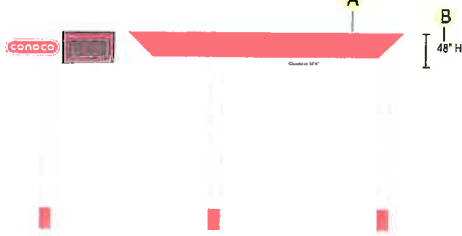

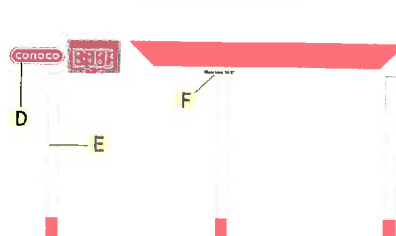

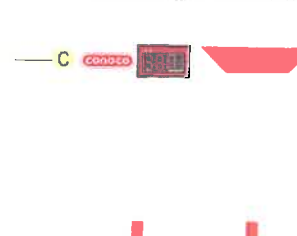
